EDITORIAL

One of my favourite degrees in Freemasonry, inter alia, is the Mark Masons' degree. If performed in the right way, the dramatic enactment of the story as it unfolds, leaves the candidate awe-bound. As the enactment progresses, he swells with pride at having been the major contributor in the allegorical activity at hand. Under the Scottish Constitution, the Mark Degree is also conferred in some Craft Lodges, though it is the first degree that the candidate encounters as he is prepared for exaltation in the Holy Royal Arch Chapter.

Another welcome step while progressing through the Mark Degree is when the candidate is called upon to select his own Mark or token, which is then recorded in the register of Marks for posterity. Mark tokens have been around a long time and one can regularly come across ones dated around 1860. There are hundreds of different tokens in Scotland and many Lodges and Chapters have their own designs. The token is given as wages during the Mark ceremony. There are a smaller number of tokens in England but America has thousands.

What is rarely known is the concept of a Mark Penny. A Mark Penny is given as token wages to a Master Mason when he receives his Mark. These Mark Pennies are full of symbolism. A standard Scottish penny has a mallet and chisel on the obverse with a thistle garland (the thistle being the national flower of Scotland.) The reverse usually has the phrase "to every man a penny".

However, many lodges have created their own Mark Pennies which have a wide variety of designs on the obverse, this adds interest to the collection! They often illustrate something important in the situated area of the lodge, such as one Lodge in Edinburgh having a train, as that center is the main railway station in Edinburgh, and another having an illustration of a king's head. Lots of Lodges celebrate Robbie Burns (who is Scotland's National bard and was a prominent freemason in his day) and these lodges have Burn's head on their tokens.

There is some information to suggest that Lodges handed out a small denomination coin such as a farthing stamped with the lodge number as long ago as the mid 19th century. There is an example of an old penny (Sterling) which was stamped 13 and given by Lodge No 13 to its Mark Masters at some time in the past. That Lodge now has a unique token of its own. The granting of a distinctive and distinguishing 'mark' to the members of an operative masons' lodge is attested in Scotland from the year 1670 when the Mark Book of the Lodge of Aberdeen was commenced and the earliest record of an 'outsider' that is a non-operative person being admitted as a member of a Mason's lodge was in 1634.

In Scotland, you can take your Mark Degree in either Lodge or Chapter, as further advancement here is dependent on obtaining your Mark. This has resulted in some Royal Arch Chapters also issuing their own, unique, Mark Pennies. These Mark Tokens are presented by Lodges/Chapters to distinguished visitors as a memento; or visitors can also offer to buy the Token from the Lodge/Chapter as a memento of their visit.

The Companions of my own Chapter Zoroaster #138, voted to issue their own Chapter Penny in the year 2003. The design of the same consists of the obverse depicting the symbolic arch with the keystone upraised, symbolically to allow sunlight (knowledge) and dispel darkness; along with the working tools in formation.



The reverse depicts the reverse of the Companion's Jewel of the Royal Arch - a double triangle, sometimes known as the Seal of Solomon, within a circle. On the interlaced triangles are inscribed the words, *Wisdom, Strength, Beauty, Peace, Concord, Truth.* Within these is the triple Tau. Along the periphery are the words "Humata, Hukata, Huvarashta", which are in consonance with the divine teachings of the basic tenets of the Zoroastrian religion as preached by Lord Zarathushtra and signify the divine ideals of good thoughts, good words and good deeds to be practiced in day to day life.

REMINISCENCES OF MY VISIT TO LODGE ROYAL JUBILEE NO. 742, SOLAPUR

One of the perks of being the District Grand Secretary is the opportunity to visit the daughter Lodges throughout the country and to interact with our Brethren, assessing their needs, strengthening acquaintances, studying different cultures, witnessing ceremonies and above all, tightening our fraternal bondage with spirit of bon-homie and camaraderie.

I had the privilege, inter-alia, of visiting Lodge Royal Jubilee No. 742 S.C. and Chapter Ganesh Gavankar No. 787 at their Installation meetings at Solapur on 28th and 27th January 2023 respectively. Though no stranger to these Masonic bodies – having visited them often – I was yet, overawed not only by the warmth of their hospitability but also by the depth of brotherhood that exists in their ranks. Right from the welcome extended by their outgoing Master Bro. Vishnu Mondhe and other brethren at our arrival till the final sendoff extended by their newly installed Master Bro. Mohan Deshpande, the visit remains etched in my mind for posterity.

Lodge Royal Jubilee is one of the Lodges which remains vibrant throughout the year as there is one or the other Masonic/Social/Cultural/charitable activity every month as gathered by me in the course of my inspection of their elaborately maintained minute book. What is amazing is that all the annual activities were contemplated in advance by the Master and implemented in toto. I came across a Charitable drive nomenclated as "Humanity Wall" within their precincts which functions on the lines of a 'garage sale'. They have also donated a Television set and distributed sweets to a school of destitute children in a remote area.

They have also donated a Water Purifier to an orphanage for women. A family trip was organized to Bamnoli forest near Mahabaleshwar with outdoor camping in tents and numerous social events. The Lodge also collectively celebrated Mahashivratri festival with religious ceremonies.

On Environment Day, they had a tree plantation drive in their compound. Yoga day was also celebrated with teachings by a professional Yoga teacher. A family get-together was observed on the "Kojagiri Poornima" day. For a change, one regular meeting was held in the pristine surroundings of Lodge Barton at Lonavala.

With nationalistic fervor, Independence day was celebrated with a Flag Hoisting ceremony in their premises. A Ladies' night was organized amid pleasant ambience of Verna Resorts. Senior members were felicitated for their contribution to Masonry at a special dinner meeting in December.

What impressed me most was their having organised as many as three charitable drives at remote sites during my visit. The first amongst them being donating an imbedded stand for a pyre at a village crematorium under Savleshwar Gram Panchayat. This cast iron contrivance, I gathered, would substantially economise the cost of wood as compared to a traditional funeral pyre.





The second was an introduction to the local villagers at an impromptu meeting with village folk at another center which has been a benefactor recipient of the Lodge, and which is held in awe of it. The third was a noteworthy munificence of





the RWM on his wedding anniversary to the 'Robin Hood Army' at another village housing a Leper's Camp, where free food was served to hundred recipients. Surprisingly, the Robin Hood Army service organisation is a voluntary force of educated youth who undertake to feed the underprivileged and the ailing every day.





Most of them had chosen Engineering as their academic pursuit, yet, at this age they had chosen to while their time by being volunteers of this worthy cause instead of indulging in other worldly pleasures.



I am thankful to Bro. Furokh Santoke, Hon. Depute District Grand Master, who accompanied me in my journey and for his assistance at all times.

Undoubtedly, on my return from Solapur, I was fully convinced in my belief that Lodge Royal Jubilee functions in a manner worthy of emulation by others.

Freemasonry is 'veiled in allegory and illustrated by symbols' because these are the surest way by which moral and ethical truths may be taught. It is not only with the brain and with the mind that the initiate must take Freemasonry, but also with the heart.

Masonry aims at the promotion of morality and higher living by the cultivation of the social side of man, the rousing in him of the instincts of charity and love of his kind. It rests surely on the foundation of the brotherhood of man and the fatherhood of God.

Freemasonry has promoted fellowship, it has nurtured brotherhood, it has practiced charity. It has education, it has been founded on truth and the cardinal virtues. But what is Masonry's greatest mission in life today? What should be the thrust of modern Masonry?
